F. NEW BUSINESS

1. Discussion and approval of I/O Solutions to be utilized as the testing vendor for police officer lateral hiring process

Deputy Chief Pretkelis advised in November of 2021, the Board members approved the new Rules and Regulations which were then sent to the Village Board for approval. The Village Board approved an ordinance to adopt the new Rules and Regulations and the information was published in the Examiner. Deputy Chief Pretkelis advised the new Rules and Regulations will subsequently go into effect ten (10) days after the publication was made.

Deputy Chief Pretkelis now asked the Board member for approval to utilize I/O Solutions as the testing vendor for the police officer lateral hiring process.

2. Discussion and update of police officer candidates

Deputy Chief Pretkelis advised the Board members the department is currently down five (5) police officers, with two (2) of those positions being unfilled from May of 2021. Deputy Chief Pretkelis provided the Board members with an update in regard to the police officer candidates that were recently provided with conditional offers of employment. Deputy Chief informed the Board members of the following in regard to the police officer candidates who were recently hired:

- One (1) took a position with another department
- One (1) resigned after the power test
- One (1) resigned after the first day of the academy
- One (1) did not pass the power test and therefore unable to attend the academy

Deputy Chief Pretkelis informed the Board members in May of 2022, the department will be requesting two (2) additional police officer positions with approval from the Village Board.

3. Discussion and approval of entry level and lateral hiring process timeline

Deputy Chief Pretkelis informed the Board members he has been working with I/O Solutions to be able to provide a timeline for the entry level and lateral hiring process. Deputy Chief distributed the timeline for the Board members to review. A discussion ensued in regard the timeline for a new list be completed, the academy dates, and the home testing process for the Commissioners who were not present during the last process.

4. Discussion and approval of the written examination for entry level hiring

Deputy Chief Pretkelis informed the Board members that departments across the area are having difficulties hiring, as well as having low turnouts for the testing process. Due to the low numbers, Deputy Chief Pretkelis informed the Board members that utilizing the questions the same for the examinations would keep costs down. Deputy Chief Pretkelis further explained it is expensive to conduct the examinations and with the low numbers, it would not be doing the tax payers a service to change the question for the examinations. Chief Ullrich also explained there is a possibility of having to conduct an additional test this year depending on the size of the list. Chief Ullrich also advised it would be different if the questions were for a promotional examination than for entry level hiring. A discussion ensued between all members present and it was determined all questions would remain the same for the examinations.

<u>COMMISSIONER SAMPEY MOVED</u>, second by Commissioner Papa to not change the written examination for entry level hiring.
