

# **Annual Report**

Dear Village Administrator Schumacher:

I am pleased to present the Bartlett Police Department's 2023 Annual Report. The report represents our unwavering commitment to "Serving with Care and Protecting with Confidence" through our continued efforts to foster positive partnerships, improve traffic safety, prevent and reduce crime, and promote employee development.

The police department was recently awarded its eighth reaccreditation from the Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA) in November. This accreditation places the department among the top 7% of police agencies in the United States and only 48 in Illinois that CALEA accredits.

Throughout the year, the department continued to find new ways to connect better and engage with the Bartlett community. It was awarded second place by the National Association of Town Watch in its population category for the 2023 National Night Out Celebration. Several police department employees and the village's benefits coordinator were honored with the Hanover Township Supervisor's Community Service Award for organizing and coordinating several community events such as the Senior Giving Tree, Stuff the Squad Toy Drive, Cupid Diaper Drive, National Night Out school supplies and non-perishable food drives to support Hanover Township residents.

The department was presented with the 2022-23 Illinois Traffic Safety Challenge second place award as part of its determined commitment to making our roadways safer. Last year, the department initiated 8,262 traffic stops, 78 DUI arrests, and 278 aggravated speeding arrests to help keep our roadways safe. It also worked with public works and neighboring communities to reduce the number of commercial vehicles traveling on North Avenue, reduce traffic crashes at the Army Trail Road and Munger Road intersection, and improve traffic flow and safety near Prairieview and Sycamore Trails Elementary Schools.

The department was dispatched to 13,397 9-1-1 calls for service and initiated 21,431 calls for service. It achieved a nearly 25% decrease in Part I & II crime rates from 2022 (3.2) to 2023 (2.4). The department also partnered with the DuPage County Health Department to provide free Narcan kits to Bartlett residents, the first program of its kind in DuPage County.

The department provided its sworn and non-sworn officers with 15,930 hours of training, including ICAT de-escalation training developed by the Police Executive Research Forum. This training equips our officers with the skills and tools they need to de-escalate situations with persons who are unarmed or are armed with weapons other than firearms and who may be experiencing a mental health or other crisis.

We are proud of our achievements and are honored to be able to serve and protect the Bartlett community. We appreciate your support and the steadfast support we receive from the Village Board and our residents. We are confident that our efforts to provide exceptional police service will continue to make Bartlett safer.







# Chief Geoffrey T. Pretkelis

Chief of Police Geoffrey T. Pretkelis was hired as a police officer by the Bartlett Police Department in November 1996. He was promoted to the rank of sergeant in 2006, appointed to the rank of commander in 2016, and then to the rank of deputy chief of support services in 2017. He was appointed as chief of police in August 2022. During his career, he has served as a patrol officer, traffic unit officer, school resource officer, and public services bureau sergeant.

Chief Pretkelis is a graduate of the FBI National Academy, Northwestern University Center for Public Safety's School of Police Staff and Command, and the Police Executive Research Forum's Senior Management Institute for Police. He earned his bachelor's degree in law enforcement and justice administration and his master's degree in business administration from Judson University. He was recognized twice with the police department's Police Officer of the Year and Leadership Award.



# **Operations Division**

The Operations Division serves as the most prominent and visible unit of the police department, with the primary responsibility of the patrol section responding to emergencies and calls for service. The Division's daily duties include investigating complaints and criminal matters, enforcing laws and ordinances, conducting patrols of neighborhoods and businesses, organizing traffic safety campaigns, and ensuring compliance with regulations. The Operations Division fosters trust and strong relationships with the community through positive daily interactions with residents, heightened visibility in residential areas, and active engagement on social media platforms..

### **Patrol Section**

The Patrol Section serves as the foundation of the police department. Its primary responsibility is to provide a safe and secure environment for the community through proactive law enforcement and positive citizen interactions.

The Village of Bartlett spans approximately 16 square miles and is home to eight elementary schools, one middle school, one high school, numerous businesses, and over 41,105 residents. When fully staffed, the Patrol Section is composed of 36 sworn patrol officers, four sergeants, and two commanders.

If a ranking member of the Patrol Section is not scheduled for duty, each shift has a pre-selected officer based on a combination of seniority and training to serve as the Officer in Charge (OIC). The OIC retains all the supervisory duties of a patrol sergeant in a temporary capacity for the course of the shift.

Each member of the Patrol Section has a 12-hour tour of duty, which comprises four alternating tours that rotate every 91 days. Officers with specialized training, including juvenile law, probationary officer field training, elderly services, firearms instruction, less lethal and Taser instruction, evidence collection, breathalyzer operation, and crisis intervention, are divided equally among the four shifts to ensure an even distribution of specialized knowledge.

As officers gain job experience, they become familiar with many of the more specialized functions of a veteran police officer. They can also choose training to further their career goals.

The officers in our department are highly trained and some of the finest examples of law enforcement anywhere. They are motivated not only to respond to calls and self-initiate police activity but also to make positive community contacts by introducing themselves to citizens in a non-enforcement manner. The Patrol Section takes pride in maintaining an outstanding relationship with the community through hard work and dedication.



















# **Canine Unit**



The Bartlett Police Department has had a canine unit since 1996, when K9 Bart became Bartlett's first canine. In 2004, K9 Brewster joined the ranks and K9 Bart retired in 2005. K9 Brewster served the Bartlett community until his retirement in 2014, when K9 Luther became Bartlett's third and final canine. All three of Bartlett's canines have served the community as patrol dogs, narcotic-contraband detection dogs, and human remains detection dogs. The Canine Unit complies with the statutory requirements of the State of Illinois, as established by the Illinois Law Enforcement Training and Standards Board, as evidenced by requalifying in narcotic detection in October 2022. K9 Luther was recertified as a patrol dog in November 2022 by the Chicago Police Department. To maintain certification standards and maximum operational efficiency, the Canine Unit conducted 83 hours of maintenance training in 2023. In addition, the Canine Unit trained with the Northern Illinois Police Alarm System (NIPAS) Mobile Field Force, the Chicago Police Department Canine Training Center, and the Cook County Sheriff's K9 Training Center for 16 hours of additional training in 2023.

# **Directed Patrol Team**

The Directed Patrol Team (DPT) is a group of three officers who perform various duties. The team includes a traffic officer, a directed patrol officer, and one DEA detached duty officer, with the DPT sergeant supervising the team. Their essential functions include coordinating compliance checks for sex offenders, parolees, and massage parlors, conducting warrant services, engaging in narcotics investigations, and conducting high-visibility traffic enforcement.

The team works flexible hours to assist with patrol functions and supplements the Investigations Section during extensive investigations. The adjustable work schedule allows the team to be proactive in addressing crime trends and community concerns. DPT relies on crime and traffic crash data to effectively deploy resources where crime and crashes occur most frequently. Additionally, the team conducts community presentations at businesses, schools, and the citizen police academies.

# **Operations Division**

# **Traffic Unit**

Throughout 2023, the Traffic Unit worked closely with the Patrol Section to prioritize aggravated speeding violations. As a result, they made 264 arrests for such violations during the year. The Traffic Unit also conducted presentations for driver's education classes at Bartlett High School on topics such as "Texting While Driving" and "How to act when being pulled over by the police," using simulators provided by AAA. They organized several traffic campaigns, including Distracted Driving and Click It or Ticket, 5/9 on 59 events, and Illinois Speed Awareness Day coordinated by Faces4.org.

In addition, the Traffic Unit conducted Scott's Law Enforcement Day, which focused on motorists who do not safely change lanes when law enforcement is conducting a traffic stop. During this initiative, they conducted 55 traffic stops, issued 41 citations and 15 warnings, and made two arrests. The Traffic Unit also helped update existing village ordinances for truck traffic restrictions and implemented a plan to aid traffic flow around certain elementary school areas.

The Traffic Unit received numerous traffic and speeding complaints throughout the village and addressed these concerns by conducting weekly saturation patrols. They also used drone cars and speed trailers to reduce speeding in these areas. Due to their successful traffic initiatives, the Bartlett Police Department was awarded 2nd place in the Illinois Traffic Safety Challenge in recognition of its creativity, commitment, and innovation in traffic safety.








### **DUI Enforcement**

During 2023, Bartlett police officers made a total of 78 Driving Under the Influence (DUI) arrests. This includes arrests for DUI/alcohol, DUI/drugs, or a combination of both. The majority of these arrests occurred in June and July 2023. It is illegal to operate a motor vehicle in Illinois with a blood alcohol concentration (BAC) greater than .08. However, a motorist can also be impaired to safely operate a vehicle when the driver is under the influence of drugs and/or with a blood alcohol concentration (BAC) .05 or higher. The police department has three specially trained Drug Recognition Experts (DREs) to help identify drugged drivers.







# 2023 Traffic Citations by Race


This illustration shows the distribution of citations broken down into the reportable racial categories. The results reflect the makeup of our community and surrounding municipalities.



# **Traffic Crash Data**









### 940 Traffic Crashes Occurred in 2023









# **Aggravated Speeding Enforcement**

In the year 2023, a total of 278 arrests were made for aggravated speeding. Out of these, 38 were Class A misdemean-or aggravated speeding violations for going 35+ MPH over the posted speed limit, while 240 were Class B misdemean-or aggravated speeding violations for going 26-34 MPH over the posted speed limit. Among the Class A misdemeanor violations, six were for speeding 45 or more over the posted speed limit, with an average excessive speed of 39.7 MPH over the posted speed limit for all Class A violations. The highest speed violation recorded was for a vehicle traveling 105 MPH in a 40 MPH zone, going 65 MPH over the posted speed limit. 




### 2023 Cases of Interest

In March 2023, Bartlett Police Department investigated a sexual assault that occurred where the offender targeted a victim who had special needs. Detectives conducted several interviews and collaborated with other jurisdictions where the offender had committed similar crimes. After an extensive investigation and detailed interviews, the offender was charged with a Class X Felony for Aggravated Criminal Sexual Assault.

In March 2023, Bartlett Police Department conducted a death investigation and learned the victim had died after consuming illegal narcotics. After several months of interviews, search warrants, and surveillance, detectives arrested the person responsible for providing the illegal narcotics to the victim. The suspect had a substantial amount of Heroin and Fentanyl in his possession at the time of the arrest, which led to charges of a Class 1 Felony for Unlawful Delivery of Fentanyl and a Class 2 Felony for Unlawful Delivery of a Controlled Substance.

In June 2023, Bartlett Police Department investigated an elder abuse case where the victim was neglected by family members. Detectives worked with the Cook County State's Attorney's Office and executed a search warrant where they discovered evidence of the abuse. Two offenders were charged with a Class 3 Felony for Elder Abuse.


In September 2023, Bartlett Police Department investigated a shooting where the offender fired multiple shots into the air while driving his vehicle in a residential area. Using automatic license plate readers detectives were able to quickly identify the vehicle the suspect was driving. After working in conjunction with the DuPage County State's Attorney's office, a suspect was taken into custody and a loaded pistol was recovered. Detectives charged the suspect with a Class 3 Felony for Unlawful Possession of a Weapon by a Felon and a Class 4 Felony for Reckless Discharge of a Firearm.

# **Support Services**

The Support Services Division is responsible for providing operational support to the police department. It comprises several units, such as Investigations (Detectives), School Resource Officers at Bartlett High School and Eastview Middle School, Community Engagement/D.A.R.E. Officers, Records Section, Community Service Officers, School Crossing Guards, Fleet Maintenance, Planning and Research (Accreditation), Police Social Worker, and the Property Custodian/Court Liaison. In 2023, Deputy Chief Naydenoff and Investigations/Support Services Commander Alagna led the Support Services Division. However, in October, Commander Rybaski replaced Commander Alagna in the Investigations/Support Services Commander position, while Commander Alagna was transferred to the Operations Division. Additionally, Sergeant Johnson moved from Operations to the Investigations Sergeant position after Sergeant Rakiewicz was promoted to Patrol Commander.

# **Investigations Section**

The Investigations Section comprises one commander, one detective sergeant, five detectives, and one investigations secretary. Our detectives work eight hours a day, five days a week, and are on-call rotation from Monday through Sunday to support the police department's goals and objectives 24/7.

The detectives investigate all types of felony and misdemeanor crimes, locate missing/runaway/endangered persons, and assist patrol officers with complex calls for service. They begin an investigation when a patrol officer refers a case that requires significant resources and additional time to complete. The Detective Sergeant reviews each case and assigns it to a detective based on several solvability factors, including the seriousness of the crime, clear descriptions that could lead to the identification of a suspect and/or vehicle, physical evidence collected, and a pattern of criminal activity or behavior. Once assigned, the detective builds and prepares the case for presentation to the appropriate state's attorney's office for successful prosecution.

In 2023, the Investigations Section was assigned 126 new cases to investigate, and 94 cases were closed. Throughout the year, detectives receive specialized training to improve their skills and knowledge in various fields, including but not limited to homicide investigations, sexual assault investigations, child abuse investigations, interview/interrogation techniques, juvenile law, and computer crimes. Detectives also maintain open lines of communication and relationships with surrounding police agencies to gather and share information.

In 2023, two detectives were trained and certified to investigate crimes involving digital evidence, specifically cellular devices. Cases in which cellular phones may have been seized may include drug investigations, death investigations, or sex offenses. Since their certification, the detectives have forensically examined seven cellular phones related to cases assigned to Investigations.

Detectives collect, store, assess, and disseminate criminal intelligence information for the Bartlett Police Department's legitimate investigative needs. They gather intelligence to identify criminal patterns and trends, suspects and criminal enterprises, and officer safety issues.

The department has one detective who is an Illinois Certified Arson Investigator, two detectives assigned to the Metropolitan Emergency Response and Investigations Team (MERIT) of DuPage County, and one detective assigned to the Sexual Assault Response Team (SART3) in Cook County.

# **Task Force Memberships**

### **Drug Enforcement Administration (DEA)**



The Mission of the DEA is to enforce the controlled substances laws and regulations of the United States and prosecute in the criminal and civil justice systems of the United States. Bartlett began a partnership with the DEA in 2012

on a task force back out of the Chicago Field Divisions. We have one officer assigned as a Task Force Officer (TFO). The TFO's duties include: mobile and aerial surveillance, transportation interdiction, working in an undercover capaci-

ty in narcotics, and monitoring federal wire taps. The seizure and forfeiture of assets derived from, traceable to, or intended to be used for illicit drug trafficking directly benefits the Bartlett Police Department.

In 2023, this DEA task force initiated 62 cases that involved two arrests and seizures of \$2.26 million dollars, 500 pounds of marijuana, 104 grams of fentanyl, 148 kilograms of cocaine,



1.9 kilograms of heroin, 3.7 kilograms of methamphetamine, 17.5 kilograms of cannabis oil, 200 cannabis cartridges, and 7 illegal firearms. Bartlett received a percentage of the currency to be used in combating local narcotic problems.

### <u>DuPage County Metropolitan Emergency Response and Investigation Team (MERIT)</u>



The DuPage Metropolitan Emergency Response and Investigation Team (MERIT) has dedicated resources for SWAT responses, crisis negotiations, major crash reconstruction, K-9 response, planned events, major crimes, crime scene investigations, intelligence gathering, computer forensics, and incident management assistance. Bartlett Police Department has one crisis negotiator, one detective and one crash reconstructionist assigned to MERIT. In 2023, the task force responded to 88 requests for service, including 47 crashes, 11 crisis negotiations, and 30 major case investigations. Bartlett requested MERIT services 1 time in 2023.

### Illinois Law Enforcement Alarm System (ILEAS)



ILEAS is a statewide police mutual aid system with over 900-member agencies. Bartlett is a member of Region IV of the ILEAS plan, which incorporates mutual aid responses for towns in Lake, Kane, Cook, and DuPage Counties. In 2023, Bartlett officers did not respond to or request mutual aid.

# Northern Illinois Police Alarm System (NIPAS)



NIPAS is a police mutual aid system operating in Northeastern Illinois. NIPAS was established by an intergovernmental agreement in 1983 and now has 103-member agencies. NIPAS has three main components: Mutual Aid System, Emergency Services Team (EST), and Mobile Field Force (MFF). The Mutual Aid System provides for participating agencies to send police officers to the requesting municipality in the event of a natural disaster or special event. EST is a full-service tactical team designed to handle high-risk incidents. MFF is a unit designed to respond to incidents of civil disturbance and consists of an arrest team, weapons team, extraction team, and command team.

In 2023, NIPAS EST responded to 40 requests for service. NIPAS MFF responded to 20 requests for service. Bartlett has one officer on the EST and one officer on the MFF.

### **Cook County Major Case Assistance Team (MCAT)**



MCAT is a multi-jurisdictional task force formed in 1998 comprised of police officers serving in the roles of detectives, evidence technicians, and a surveillance team. MCAT is activated when a major incident occurs that could overwhelm an agency, such as homicides, kidnappings, and other major crimes. MCAT officers are specifically selected based on their training, experience, and talents. MCAT officers' tasks include; canvassing neighborhoods, interviewing witnesses and suspects, providing technical support, and collection of evidence. In 2023, Bartlett had one officer assigned to the evidence team. MCAT was activated 33 times in 2023 resulting in 2489 investigative hours, 1710 hours of evidence processing and 762 hours of physical surveillance. Bartlett did not request MCAT services in 2023.

### MCAT Serious Traffic Accident Reconstruction (STAR)



The STAR Team is a traffic crash response and reconstruction team. The MCAT STAR team responds to fatal motor vehicle crashes or motor vehicle crashes where death is likely, and multiple vehicles are involved. Bartlett has one officer assigned to the STAR team. In 2023, Bartlett requested the MCAT STAR team for one fatal crash. MCAT STAR team responded to 18 crashes.

# **Records Section**

The Bartlett Police Records Section operates 24/7, providing assistance to the community of 41,000 residents across three counties: Cook, DuPage, and Kane. The section is equipped with eight full-time clerks, one records supervisor, and two part-time data entry clerks, all trained to handle residents' concerns and provide the best solutions.

The Records Section carries out various tasks for the department and the community, from performing records checks, maintaining the department's active warrant files for each county, preparing court jackets, and assisting with overnight parking requests and vacation watches, to approving calls for service, monitoring local police radio channels, and transmitting tickets to the courthouses. The section also works closely with legal, county, state, and federal partners.



Additionally, the Records Section is responsible for accommodating Maverick, the police department's comfort dog, when he stays at the station overnight.

# **Local Adjudication and Administrative Tow Hearings**

Bartlett officers issued 90 local adjudication citations and 1,880 parking citations for the year. Of these citations, a total of 482 were heard by the hearing officer, of which \$5,485 fines were imposed. The hearing officer also dismissed a total of 40 citations. Bartlett police also impounded 130 vehicles that qualified for administrative tows after the motorists were arrested for criminal offenses listed in our village ordinances. The village collected \$75,000 in fines.



### School Resource Officers

Our School Resource Officers are Officer Tracey Dendinger at Bartlett High School and Officer Pat Carey at Eastview Middle School. They are supervised by Support Services Sergeant Greg Milos.

### **Eastview Middle School SRO**

Officer Carey's primary goal is to provide a safe learning environment for Eastview's students, staff, and visitors. He maintains an "open door" for school safety and behavior concerns and works with the Eastview community to solve these issues. Officer Carey also builds relationships between students and the police department and maintains a mentoring role, especially with potentially at-risk students.

In 2023, Officer Carey taught Project Alert to 391 7th-grade students at Eastview Middle School. Project Alert is an in-depth course discussing the consequences of smoking/vaping, alcohol, marijuana, and opioid abuse. Officer Carey also started his fourth year teaching a self-created "Digital Citizenship/ Internet Safety" class. This class focuses on internet-specific laws, avoiding victimization, and the long-term consequences of social media usage. The class is constantly updated and has now been shared with dozens of School Resource Officers (SROs) in the state to help educate their students. Officer Carey also speaks with classes on subjects such as the Bill of Rights, sound decision-making, and careers in law enforcement.

In 2023, Officer Carey continued to lead the Travis Manion Foundation's (TMF) "Character Matters" club at EVMS. This club was one of the first TMF clubs approved for the middle school level in the country. The TMF club meets monthly to discuss ways to improve the school and community, build character, and work on self-development.

In addition to serving as a Director of the Board for the Illinois School Resource Officer's Association, Officer Carey achieved National Practitioner status from NASRO, "the world's leader in school-based policing." Officer Carey was one of only two SROs in the state and 51 in the nation to achieve this distinction.

Officer Carey was also an assistant coach for several EVMS teams during the school year. Go Wolves!









School Resource Officers (SRO) oversee keeping the staff and students safe each day and focus their time on building positive relationships within the school. Officer Ray Garcia served as the SRO for Bartlett High School, where he also assisted in teaching a law class and driver's education by offering valuable information and Q&A sessions. Officer Garcia also attended school dances and school athletic activities and served as a mentor for the Bartlett Police Department Teen Police Academy.

In the fall of 2023, Bartlett High School received a new SRO, Officer Tracey Dendinger, who continues to find ways to engage students and be a positive role model for others. Most notably, this year, Officer Dendinger coordinated an effort involving the Bartlett High School Autos Class, who volunteered to repair a vehicle for a local homeless resident. This resident was exceedingly grateful, and the students were proud of their hard work and good deeds. Go Hawks!









# **Community Engagement Unit**

The Community Engagement Unit takes pride in its positive relationship with the community. They educate and assist residents and businesses through various programs like Neighborhood Watch, Dog Walker Watch, Business Watch, and C.P.T.E.D (Crime Prevention through Environmental Design). They conduct Bank Robbery Awareness Training, Active Shooter/Safety presentations at area businesses and churches, and Safety/Bullying Talks at local schools, daycare facilities, and churches.

Throughout the year, police officers participate in Run, Hide, and Fight Drills at all the Bartlett schools. They also conduct functionality tests with emergency critical fobs for the schools and check the times when dispatch receives alarms to ensure a quick response.

The Community Engagement Unit hosts Coffee-n-Chats and presentations at the Victory Centre for the residents. They provide an overview of the Bartlett Police Department, discuss Scams and Cons, and talk about Maverick, their Facility Dog. They also have coffee and snacks with the residents to discuss ideas they might have for future presentations. Their Neighborhood Watch and Bartlett Paws on Patrol Dog Walker Watch programs educate citizens on paying attention to and reporting suspicious activities in their neighborhoods while walking, riding their bicycles, or walking their dogs. These programs are essential to the safety of the community. In June 2023, the Community Engagement Unit hosted its annual outdoor Dog Walker Watch Summer Training and Social Event. They continue to have fantastic participation from residents, with several newcomers requesting to be added to their email list to receive information about events in town, future training dates, and any reported issues.

The Community Engagement Unit participated in several programs and activities, including safety and bullying talks with Girl and Boy Scout troops, daycares, churches, and preschools. They also conducted school and business safety presentations and Active Shooter training sessions. They gave out 7-Eleven "Operation Chill" free Slurpee coupons, conducted Tobacco/Alcohol/Vape compliance checks, and held "Mystery Reader" sessions at elementary schools. They also gave police station and squad car tours, organized MLP/ ILP classroom holiday celebrations and educational programs, and conducted the Village School Crossing Guard training program. They also attended the Illinois Juvenile Officers Association and Illinois D.A.R.E. Officers Association conferences.







# D.A.R.E. Program

The D.A.R.E. (Drug Abuse Resistance Education) Program is a collaborative effort between law enforcement, elementary schools, and parents to help students make healthy choices, say no to drugs, resist peer pressure, and stand up to bul-

lying. In 2023, over 600 5th graders from six elementary schools in Bartlett participated in the D.A.R.E. program. We also taught a modified D.A.R.E. curriculum to include the M.L.P. (Modified Learning Program), I.L.P. (Individual Learning Program), and LD/BD (Learning Disabled and Behavioral Disorder) students who attend one of the four elementary schools that offer these types of programs.

The D.A.R.E. curriculum includes lessons on the dangers of alcohol, tobacco, vaping, and marijuana, positive and negative peer pressure, internet safety, confident communication and resistance strategies, risks and consequences, and how to deal with bullying situations.

In 2023, the Illinois Juvenile Officers Association awarded Officer Vicky Anderson the Illinois D.A.R.E. Officer of the Year award. Officer Michael Bingham was certified as a D.A.R.E. Instructor and began teaching in 2023. Officer Tracey Dendinger celebrated her last D.A.R.E. graduation as she moved to her new assignment at Bartlett High School.











# **Community Service Officers**

The Bartlett Police Department has assigned four full-time Community Service Officers (CSOs) to work in two shifts weekly. The day shift starts at 7 a.m. and ends at 5 p.m., while the evening shift begins at 10 a.m. and ends at 8 p.m. Each CSO has its own Ford F-150 patrol vehicle to handle a wide range of calls and assignments.

The most frequent calls that CSOs receive include vehicle lockouts, animal complaints, enforcement of village ordinances (e.g., parking violations, open burning, dumping), roadway hazards, traffic direction during various incidents, and investigation of private property crashes. Additionally, CSOs perform ink and digital fingerprinting of residents for employment purposes and handle investigations of criminal complaints where the offenders are unknown, such as theft, criminal damage to property, and iuvenile nuisance issues.

Apart from these duties, CSOs also perform other tasks, such as deploying unmanned police cars, radar speed trailers/ speed sign deployment, vacation house checks, filling in for Records personnel during staff shortage or meal breaks, acting as Court Liaison Officers, and assisting in evidence destruction, prescription drug drop-off events, and special events. They are often included in the village's social media for public safety announcements or to promote the department during holidays and special occasions.

CSOs are responsible for maintaining and managing department assets, infrastructure, and grounds, including servicing all fleet vehicles, the traffic signboard, and light towers. When fleet vehicles, equipment, and other surplus department property reach the end of their useful life, CSOs sell them through the Obenauf auction site.







# Accreditation



The Commission on Accreditation for Law Enforcement Agencies, Inc. (CALEA), awards law enforcement accreditation to agencies that voluntarily submit to this rigorous process. Accreditation recognizes professionalism, distinction, competency, and our ongoing pursuit of excellence. There are 462 CALEA standards in the law enforcement program for which agencies are expected to maintain updated written

policies and annual proofs of compliance. The Bartlett Police Department is among only 48 police agencies in Illinois and less than 7% of police agencies in the United States which are currently CALEA accredited.

In our continuing updates of the police department policy manual, we revised 48 existing orders and added 2 new ones in 2023.

We successfully completed the fourth annual CALEA web-based review of our standards compliance in June 2023. Our site-based review took place in July 2023 with Assessor Jack Moulton from Hagerstown, Maryland. Department and Village staff attended the Fall 2023 CALEA Conference in Bellevue, Washington in November 2023, where Bartlett Police Department received its eighth reaccreditation award since its initial accreditation in 1997.




# **Emergency Management Agency**

The Bartlett Police Department's Emergency Management Team comprises about 15 members, including the deputy chief of operations, commander/emergency management coordinator, sergeants, officers, community service officers, public works, and village administration. Our team assists the Village of Bartlett during large-scale events such as the Independence Day Festival and Parade, National Night Out events, and many other community events. Our team's emergency management efforts include event planning, public education, training, and other preparedness activities.



The Village of Bartlett remains committed to responding to all natural and man-made disasters or active threat situations utilizing trained personnel, equipment, and National Incident Management System (NIMS/ICS) protocols. Our team holds quarterly training meetings and expands our training to encompass various topics in emergency management, including planning special community events, developing a Village Comprehensive Emergency Preparedness Plan, and conducting tabletop exercises, functional exercises, and full-scale exercises. The team also works together to develop emergency plans and large-scale training and works together during real-world emergencies. Although some hazards are less frequent than others, the Emergency Management Team facilitates additional planning and training on hazards with the highest potential, including severe weather events, active threats, public health emergencies and pandemics, winter weather events, and transportation emergencies.

The Village of Bartlett is also a member of the DuPage County Incident Management Assistance Team (IMAT). As agencies face more complex incidents, the need for well-trained, experienced experts in incident management is becoming more necessary. IMAT will help the Village of Bartlett with the command and control of large-scale events such as active shooter situations, protests, and any large-scale incident requiring many resources. When requested, IMAT will send sworn officers and supervisors from DuPage County municipalities to assist with the planning and handling of the incident. The village's Emergency Operations Plan was updated and approved by the Cook, Du-

Our team of forensic specialists, also known as Evidence Technicians (ETs), is a crucial component in the successful identification and prosecution of offenders in criminal courts of law. Whenever a crime is discovered, a police officer calls on an ET to assist with the investigation. Our ETs are trained and equipped to handle various types of crime scenes, from crimes against persons and property to both natural and suspicious deaths.

The team is supervised by a sergeant and comprises 21 ETs, including a Certified Arson Investigator and a Computer Forensic Expert. These ETs are assigned to different sections throughout the police department and perform evidence-processing duties in addition to their regular work assignments. Some ETs also belong to specialized teams such as the Major Case Assistance Team (MCAT) for Cook County, the Serious Traffic Accident Reconstruction (STAR) Team for Cook County, and the Metropolitan Emergency Response and Investigations Team's (MERIT) Major Crash Reconstruction Team for DuPage County.

ETs process crime scenes involving death investigations, burglaries, stolen motor vehicles, armed robberies, firearm cases, personal injury and fatal traffic crashes, and criminal sexual assaults, among others. They use various methods of evidence collection, such as digital photography, fingerprint/footprint lifting, fingerprint fuming, impression casting, alternative light source imaging, gunshot residue testing, and DNA recovery. To enhance their skills, senior ETs share their decades of experience with newer ETs through increased in-house training.

This year, two community service officers were certified as ETs by attending the 40-hour Basic Evidence Technician training course.

# **Property Control Unit**

The Property Control Unit, led by Property Custodian Mark Hogan and his supervisor, Sergeant Greg Milos, is responsible for the proper storage, control, and security of all evidence and property held by the police department. The Property Control Unit has a secure storage space of over 1600 square feet located in the basement of the police building.

The first floor of the Property Control Unit consists of an evidence processing area along with 24 temporary evidence lockers and 12 refrigerated evidence lockers for evidence submitted to Property Control. Every piece of evidence or property that enters the Property Control Unit is entered into a computerized database using the BEAST software system.

Each inventoried item in the database is linked to a specific incident number, with a description of each item, the name of the police officer who inventoried the item, and the victim/complainant information about the case. A barcode sticker is assigned to each inventoried item, and a specific storage location is given to it in Property Control. Examples of inventoried items include cash, guns, jewelry, weapons, drugs, biological samples, latent fingerprints, and bicycles.

The Property Custodian is responsible for submitting evidence for testing and analysis to the Illinois State Police Crime Lab and the DuPage County Forensic Science Center within a reasonable time frame. Evidence and property are destroyed or disposed of according to court orders, expiration of the statute of limitations, and a six-month time frame on found property.

When an owner cannot be found, the property may be auctioned off, and unclaimed bicycles may be auctioned off or donated to a not-for-profit organization that provides jobs for youths fixing up the bicycles.

In 2023, the Property Control Unit received 1,502 items into Evidence/Property Storage. Of these items, 66 were transferred to other agencies, 130 were sent to crime labs for testing, 92 were returned to owners, 1045 were destroyed, and seven were auctioned. Additionally, 299 lbs. of unwanted medications were dropped off at free public Drug Drop-Off events at the Village Hall and taken to the DuPage County Health Department for incineration.


#### **Field Training Program**

The Police Officer Field Training and Evaluation Program is a 17-week training program that takes place after the academy. It includes intense, formal, standardized, and structured one-on-one training with four field training officers. The program aims to equip a new officer with the necessary skills and confidence for solo patrol. In 2023, nine new officers completed the program. Furthermore, four officers became field training officers by completing the 40-hour Basic Field Training Officer school.

The Sergeant Field Training and Evaluation Program provides one-on-one training for newly promoted sergeants to learn through systematic instruction with an experienced sergeant. The program aims to assist the new sergeant in becoming a fully competent first-line supervisor who can perform their duties with confidence and skill. In 2023, one sergeant completed the program.

The Community Service Officer (CSO) Training and Evaluation Program is a ten-week, one-on-one training program with two different field training officers. It aims to prepare the CSOs to perform their daily duties and familiarize themselves with the other roles they will fulfill within the department, including court liaison, records clerk, and evidence technician. In 2023, one new CSO completed the program.

The Records Section has its own Training and Evaluation Program for new Records Clerks. In 2023, three new Records Clerks successfully completed the program.



#### 9-1-1 Communications

DuPage Public Safety Communications (DU-COMM) is an intergovernmental agency in Wheaton formed in 1975 to provide emergency communication services to police, fire, and emergency medical services. It is one of the largest consolidated public safety communications centers in Illinois and currently serves forty-four agencies and over 850,000 residents in DuPage and neighboring counties. DU-COMM processes over 1.2 million phone calls each year, including over 750,000 police and Fire/EMS incidents. In 2023, DU-COMM handled 34,828 incidents for the Bartlett Police Department. DU-COMM dispatched 13,397 calls for service and there were 21,431 officer-initiated activities.

#### **Drone Team**

Bartlett Police Department's drone program has expanded. Drones were deployed at the 2023 Fourth of July Festival and Independence Day Parade after state law changed to permit their use at public gatherings.

In addition to the training and study required to maintain an FAA Part 107 Remote Pilot License, all drone operators train regularly in a variety of locations and settings to ensure operational proficiency. Seven officers are trained as drone operators.

Illinois statutes now allow police departments to use drones to:

- Monitor in real time participant safety at a public gathering, or create maps and determine appropriate access routes, staging areas, and traffic routes at a public gathering.
- Provide traffic collision and crime scene evidence photography.
- Prevent imminent harm to life when swift action is needed, or to forestall the imminent escape of a suspect or the destruction of evidence.
- Locate a missing person, engage in search and rescue operations, or aid a person who cannot otherwise be safely reached.
- Locate victims, assist with immediate victim health or safety needs, or coordinate the response of emergency vehicles and personnel to an emergency during a dispatched call for service.
- Assess a disaster or public health emergency.
- Counter a high risk of a terrorist attack by a specific individual or organization.

#### **Recruitment Team**

Recruitment for qualified candidates is an ongoing process at the Bartlett Police Department, and the recruitment team conducts formal meetings and recruitment strategies in advance of all police officer testing processes. Additionally, the team participated in four law enforcement job fairs in 2023.

Per Illinois state law, the Village of Bartlett conducts written examinations to create a list of eligible police officer candidates. Any hiring to fill vacant sworn officer positions must be done with these eligibility lists. In 2023, the recruitment team and the Board of Fire and Police Commissioners used a validated online written examination

to identify qualified applicants. This process has proved to be highly reliable and yielded multiple qualified applicants, especially when compared to other area police departments that have seen fewer interested applicants in their field.

The first final eligibility lists for entry-level and lateral police officers in 2023 were registered in June. However, due to many police officer vacancies, the eligibility lists were exhausted, and a second recruitment campaign was launched in the same year. As a result, the second final eligibility list for 2023 was registered in October. A total of 13 qualified police officer candidates were sworn in as Bartlett police officers in 2023.

As 2023 was ending, the recruitment team and Board of Fire and Police Commissioners realized that the October 18, 2023, final eligibility list would be exhausted in January 2024. To address this, the recruitment team began coordinating a third active recruitment campaign during the Village's same fiscal budget year to establish another final eligibility list for entry-level police officers.

Entry-level police officer applications are expected to go live in January 2024, and applicants are anticipated to participate in their online written examination in the first week of April 2024. Those who pass the written examination will be allowed to go before the Board of Fire and Police Commissioners for an oral interview. Upon completing the oral interviews, the final eligibility list will be registered in May 2024.



#### **Court Liaison Officer**

The Bartlett Police Department's Court Liaison Officer, Mark Hogan, has various responsibilities to ensure a smooth court process. The Court Liaison Officer:

- Assigns police personnel court dates for court appearances in Cook, DuPage, and Kane Counties.
- Coordinates and schedules each officer's felony, misdemeanor and local ordinance court calls in each respective court venue.
- Retrieves court files and evidence for each court call.
- Delivers subpoenaed materials prior to the commencement of the court call.
- Transmits citations, bonds and warrants to the Clerk of the Circuit Court.
- Maintains professional, positive relationships with judges, state's attorney's offices, court clerks, and attorneys to ensure open communication, effectiveness, and cooperation with the Bartlett Police Department.



At court appearances, the Court Liaison Officer:

- Documents officer attendance.
- Ensures officers possess appropriate court materials.
- Monitors and documents dispositions of each case.

In 2023, the Court Liaison Officer, in addition to his property and evidence duties:

- Attended 51 Cook County misdemeanor, local ordinance, and traffic call court dates.
- Attended 41 DuPage County misdemeanor, traffic, and local ordinance court calls.
- Uploaded 362 evidentiary and records-related items to Tech Share software to comply with DuPage County's State Attorney's Office discovery requests.
- Delivered 145 sets of subpoenaed materials to Cook and Kane County court agencies.
- Mailed approximately 75 post-tow notice letters to vehicle owners whose vehicles had been towed.

# **School Crossing Guard Program**

The School Crossing Guard Program is responsible for ensuring the safety of students as they walk to and from school. Bartlett Police Department presently has 22 crossing guards who cover 18 crossing posts in the morning and afternoon on school days. These crossing guards are responsible for six elementary schools and one middle school within the Village.

All crossing guards are required to attend an annual training session before crossing students at their posts. This training session includes a written exam and an outdoor practical session as part of the requirements. In addition, our crossing guards are provided with basic first aid and CPR training.

Our crossing guards receive performance evaluations at their assigned posts twice a year. They build lasting relationships with the children and parents who walk to and from school every day.

### **Round Table Team**

The Round Table Team was formed in 2011 to discuss matters concerning department policies and procedures, problem solving, and organizational culture. The Round Table Team consists of twelve department members who serve a staggered two-year term and have differing responsibilities and titles. The team works together to make binding decisions as representatives of the entire department.

In 2023, the Round Table Team worked on the following topics:

#### **Training**

In 2023, police department employees attended 15,930 hours of training. The training provided to sworn and non-sworn department personnel includes many sources, such as computer-based programs, subject-matter experts, roll call discussion, in-house instruction, Northeast Multi Regional Training (NEMRT), Northwestern University Center for Public Safety (NUCPS), Police Executive Research Forum (PERF), and the Illinois Law Enforcement Training Standards Board (ILETSB).



# School of Police Staff and Command

Sergeant Brian Simone completed the 10-week School of Police Staff and Command program from Northwestern University Center for Public Safety in Schaumburg between September 9, 2023, to December 1, 2023. This program is designed to provide experienced law enforcement professionals with leadership and management education to prepare them for senior command positions. The program has been attended by over 14,500 students from both national and international police agencies. The School of Police Staff and Command program covers twenty-seven core instruction blocks, including planning, policies, media relations, organizational behavior, budgeting and resource allocation, human resources, contemporary policing, and more. Additionally, the program utilizes additional instruction blocks during each session to provide a comprehensive understanding of critical commandlevel content.

# **Fair and Impartial Policing**

Fair and Impartial Policing is a modern and scientific training program that aims to promote unbiased policing. The program acknowledges that everyone has implicit biases, and these biases can unknowingly affect well-intentioned individuals. All members of the police department staff have undergone this training. The program educates participants on the adverse effects that hidden biases can have on their behavior and perceptions. Additionally, participants are presented with various scenarios to address sensitive, bias-related issues. After completing the training, participants are equipped with tools and skills to manage and reduce their individual biases. The ultimate goal of Fair and Impartial Policing is to foster better relationships between the police department and the diverse communities they serve and protect. In 2023, four new Bartlett police officers received the Fair and Impartial Policing training.

# **Department Code of Ethics**

#### POLICE OFFICERS:

As a law enforcement officer, my fundamental duty is to serve the community; to safeguard lives and property; to protect the innocent against deception, the weak against oppression or intimidation and the peaceful against violence or disorder; and to respect the constitutional rights of all to liberty, equality and justice. I will keep my private life unsullied as an example to all and will behave in a manner that does not bring discredit to me or to my agency. I will maintain courageous calm in the face of danger, scorn or ridicule; develop self-restraint; and be constantly mindful of the welfare of others. Honest in thought and deed both in my personal and official life, I will be exemplary in obeying the law and the regulations of my department. Whatever I see or hear of a confidential nature or that is confided to me in my official capacity will be kept ever secret unless revelation is necessary in the performance of my duty. I will never act officiously or permit personal feelings, prejudices, political beliefs, aspirations, animosities or friendships to influence my decisions. With no compromise for crime and the relentless prosecution of criminals, I will enforce the law courteously and appropriately without fear or favor, malice or ill will, never employing unnecessary force or violence and never accepting gratuities. I recognize the badge of my office as a symbol of public faith, and I accept it as a public trust to be held so long as I am true to the ethics of police service. I will never engage in acts of corruption or bribery, nor will I condone such acts by other police officers. I will cooperate with all legally authorized agencies and their representatives in the pursuit of justice. I know that I alone am responsible for my own standard of professional performance and will take every reasonable opportunity to enhance and improve my level of knowledge and competence. I will constantly strive to achieve these objectives and ideals, dedicating myself to my chosen profession...law enforcement.

#### CIVILIAN EMPLOYEES:

I acknowledge respect for human life, recognizing diversity among the members of the community and department I serve. I will exhibit honesty and integrity through ethical behavior. I will be obedient to the laws of the Village of Bartlett, the State of Illinois and the United States of America. I will not, in the performance of my duty, work for personal advantage or profit. I will, at all times, recognize that I am a public servant, and that ultimately I am responsible to the public. I will give the most efficient, impartial and courteous service of which I am capable at all times. I will regard my fellow employees with the same standards as I maintain for myself. I will accept responsibility for my actions. I will do only those things that will reflect honor on my fellow employees, my supervisors, my agency and myself.



# **Internal Affairs Report**

It is our policy to receive and investigate all complaints related to internal discipline in a manner that will assure the community of prompt corrective action when department members conduct themselves improperly, and to protect the police department and its members from unwarranted criticism pursuant to their discharge of official duties. In 2023, there were five (5) formal complaints against department members. Of those cases, four (4) were sustained and resulted in some form of disciplinary or counseling action. Bartlett Police Department investigated twenty-three (23) informal complaints for violations of departmental rules, policies, or procedures in 2023. Four (4) complaints were initiated by members of the public and nineteen (19) complaints were made internally by the department. Of those cases, nineteen (19) were sustained and resulted in some form of disciplinary or counseling action.

#### Crisis Intervention (CIT) Police Response

In recent years, the approach to crisis intervention in policing has changed to include a two-pronged strategy. The first is the initial response by front-line crisis intervention team officers who are trained to recognize and respond to mental health episodes. They receive extensive training in mental health awareness, communication, and de-escalation tactics.

While officers have been vital to crisis intervention, the addition of the Police Social Worker program has filled the void of having only crisis intervention and moved the law enforcement profession into crisis management. The prolonged follow-up responses by the social worker have changed the effectiveness of the police in the community. Our police social worker, Alexandra Berkman, has become a liaison for the police department to connect people with mental health resources. Many families struggle with mental health issues, causing feelings of hopelessness and despair. Alexandra has lessened that burden by educating persons and their families about available opportunities and programs. This leads to fewer repeat calls from the same locations for the same reasons. Alexandra has become an essential source of support for the community.

In 2023, the Bartlett Police Department added four new officers to the Crisis Intervention Team and responded to the following calls for service:

- 110 mental health-related calls, ranging from individuals feeling suicidal to those with diagnosed or undiagnosed mental illnesses or those suffering from drug/alcohol addiction
- 467 domestic-related calls for service
- 96 drug and/ or alcohol related calls for service
- 0 suicides

#### **Police Social Worker Program**

The Bartlett Police Department has been working with Northeast DuPage Family and Youth Services (NEDYFS) since December 2021 to provide the department with a part-time licensed social worker. Due to the evident need for a full-time social worker, a contract for a full-time social worker was approved in April of 2023, and Alexandra Berkman started working as a full-time licensed social worker at the department in February of 2023. Alexandra has a Bachelor's Degree in forensic psychology and foreign languages and culture from Western Illinois University, and completed her Master's Degree in social work at Aurora University. She specializes in forensic social work and enjoys collaborating with law enforcement to serve and support vulnerable populations. Alexandra has worked with victims and survivors of domestic and sexual violence and is a Certified Domestic Violence Professional. She interned at the West Chicago Police Department in their social services unit and has experience working in crisis centers, shelters, and child welfare.

The police social worker's role is to provide various services and support to individuals and/or families who have come into contact with law enforcement. These services include individual, couples, and family counseling, case management services, emergency/ trauma response services, crisis intervention, community education, and referral services. The program aims to support community members, strengthen the bond between the police department and community, reduce non-related police calls, and offer alternative routes for at-risk youth to enter the justice system. In 2024, two diversion programs will be implemented for juveniles. One diversion program will be specifically for substances (alcohol, cannabis, and tobacco products), which the police social worker will facilitate. The other diversion program will be for at-risk youth who will be referred to the ReDirect Program, facilitated by other NEDFYS staff members. These programs will allow juveniles to redirect their behaviors and prevent further involvement in the justice system.

The social worker program works by receiving direct referrals from officers when they encounter individuals who may benefit from social services. The social worker will then

contact individuals to assess and determine which services may help them and/or their families. If the individual and/or family needs more immediate services, officers can call the social worker to respond to the scene. This rapid-response model was implemented to offer immediate support to community members.

In 2023, there were 196 referrals to the police social worker program, which was an increase of 41% from 2022. The program's future consists of implementing the diversion programs and continuing to support community members. The social worker program will continue to foster collaboration with various village departments, our staff psychologist, community providers, and local schools to better serve the community.

#### Police Psychologist

Dr. Kammie Juzwin is the department's psychologist and continues to provide mental health support for officers and community members. Having a department psychologist is a valued resource for the department. Through collaboration with the department's police social worker, employees are equipped with tools they need to provide the best service for the members of the Bartlett community. Some of Dr. Kammie's activities this past year included:

- Helping develop the emergency management protocol for taking care of our employees during any potential crisis.
- In conjunction with the police social worker, helping development an emergency management protocol to support the needs of our community in the event of a potential crisis.
- Training on writing mental health petitions and recognizing serious mental health crisis response where the person may need hospitalization.
- Supporting employees in situations with critical incident stress exposure, and organizing and supporting critical incident debriefing services.
- Spending ride-along time with officers and consulting on cases with officers.
- Talking with employees about ongoing stress and challenges they may be facing in their personal lives.
- Consulting with supervisors about how to support employees and identify avenues for helping support, guide through, or resolve challenges that might be impacting them at work.
- Supporting employees with loss and grief issues.
- Supporting employees with job related and career transition issues.
- Talking with family members as needed.

- Roll call involvement and answering questions about mental health.
- Consulting with administration about department issues, employee health, and support.
- Consulted with a couple which was dealing with very difficult mental health problems.

In 2023, the Bartlett Community Care Collective continued with their mission of providing various services to members of the Bartlett community who are in need. The collaboration between BC3 and the Bartlett Police Department has provided officers with additional resources that can be delivered directly to community members. Some of the assistance BC3 provided to community members last year included:

The Bartlett Police Department Chaplain, Breanne Fuelling, is the Next Generation and Counseling Ministry Director at the Village Church of Bartlett. Breanne is one of the primary liaisons for the Bartlett Community Care Collective (BC3). Police Chaplains provide comfort and counseling to members of the police department and their families when they have been involved in a critically stressful situation, or if they seek counseling for personal reasons. Police Chaplains may also assist the public and

- Provided a resident with a \$112 check for groceries for a resident suffering from PTSD and depression.
- Provided hotel room assistance for an elderly resident displaced from her home.
- Provided a resident with a \$700 check for a residential security deposit.
- Provided a resident with a \$80 check for storage unit assistance.
- Purchased a bassinet for a foster care family.
- Gave out food and snack gift bags for elderly people in the community.

#### Facility Dog—Maverick

Maverick is a three and a half-year-old Golden Retriever who was donated by Canines 4 Comfort, a 501(c)(3) organization that provides psychiatric service dogs and emotional support animals to organizations. Canines 4 Comfort continues to provide training for Maverick and his handlers. Nature's Select Pet Food donates his food, Motif Grooming grooms him monthly, and he receives regular checkups at Heartland Animal Hospital. The program is supervised by a Facility Dog Coordinator, a Primary Handler, and three secondary handlers. Maverick's functions include:

- Providing aid and comfort to persons, groups, and communities impacted by violence, tragedy, or traumatic events
- Assisting during investigations involving children or adults, to reduce their anxiety and increase communications
- Providing comfort for people during times of crisis
- Providing comfort to members of the department.

He is deployed routinely for a variety of public events and also in private situations where he assists families or those in need. Maverick and the Community Engagement Team have made appearances at each of the U-46 schools in Bartlett and attended community events such as Touch-a-Truck, National Night Out, Merry and Bright, and many others.

He has continued training throughout 2023 with Canines 4 Comfort and other police comfort dogs. When not deployed, Maverick spends his day throughout the police department. In the evening times, Maverick either goes home with a handler or keeps the Records Section company, where he has his own space with a bed and toys.

BARTLETT POLICE INVESTIGATE FATAL MOTOR VEHICLE CRASH

In Invirsally, August 31, 2023, at approximately 700 a.m. is arriest Police Department and the south Egin Fire Protection District responded to the intersection of IL Boute 25 and Keynon Road to investigate a motor vehicle crash involving a 2002 Honda Criric that was occupied by four south Egin High School students and a 2007 Mack semi-tractor trailer.

The male driver of the Mack semi-tractor trailer, the female driver of the Honda Civic, and a female passenger from the Honda Civic suffered non-life-threatening injuries and were transported to area hospitals. Another female passenger from the Honda Civic was pronounced dead at the scene. School District U-46 Crisis feam has been activated at South Eigin High School. #### Vehicle Fleet

In 2023, Bartlett Police Department received five new 2023 marked Ford Expedition police vehicles that have been equipped with the latest safety features:

- 75-MPH rear impact crash tested.
- Advanced structural safety technology that helps absorb the energy of a collision and direct the impact forces away from the occupants.
- Safety canopy system that deploys side-curtain airbags for outside passenger head protection.
- SPACE (Side Protection and Cabin Enhancement) Architecture.
- Heavy-duty front suspension, braking system, wheels, and tires.
- The heavy-duty subframe and powertrain mounts have been reinforced to withstand the extreme stress and tension encountered on the job.
- Hands-free Bluetooth.
- In addition to numerous red and blue emergency flashing lights installed on our police vehicles, we added reflective chevron decals on the tailgates of our new cars. We placed reflective tape on all vehicle side doors of our fleet so they are more visible in day/night conditions.





# **Property Auction Sales**

In 2023, Bartlett Police Department did not auction any worn, and/or no longer usable vehicles or other property through a public auction.

#### **Grants**

The police department received \$36,238.78 in federal, state, and organizational grants in 2023. Bartlett Police Department continues to pursue available grants to help fulfill our mission.



- The Bulletproof Vest Partnership Program from the U.S. Bureau of Justice Assistance reimbursed the Village of Bartlett \$4,009.58 in 2023 for the purchase of protective body armor for our officers. We were also approved for the next round of grant funding of \$3,465.00 for future body armor purchases. Body armor is replaced every five years for each officer and this grant reimburses half the cost of replacement.
- \$25,091.70 was granted from the Illinois Department of Transportation Traffic Safety Division in 2023 for extra traffic enforcement in the areas of alcohol-related violations and safety belt enforcement. These traffic enforcement campaigns coincide with major holidays and are publicized to remind drivers not to drink and drive and to wear seat belts. The department has applied for the next round of IDOT traffic enforcement grants for FY2024-2025.



• Our Village's risk management agency, the Intergovernmental Risk Management Agency (IRMA), offers a series of grants to municipal members in areas that reduce risk and liability costs. The police department applied for and received an IRMA Accreditation Grant award in 2023 in the amount of \$3,500.00 to help defray the cost of the police department's 2023 reaccreditation fee. An accredited police department helps reduce liability costs to insurers.



The police department applied for and received a Powering Safe Communities grant sponsored by ComEd and administered by the Metropolitan Mayors Caucus. The department was awarded \$3,637.50 for its automated external defibrillator (AED) upgrade project. Our police department is now training village employees as well as its own employees, which will expand the number of trained AED users to all village buildings, including the village golf course. The grant amount covers the purchase of new AEDs and a training AED.
