# SPECIAL CAPITAL PROJECTS ISSUE - June 7, 2024

#### **Project Name: Water Main & Lead Service Replacement**

**Description:** This multi-year (FY2023 - FY2029) project consists of replacing water mains that are experiencing frequent main breaks or have capacity concerns.

**FY2024 - 2025: North Ave. & Oak Ave. water main & lead services replacement** Approximately 12,000 feet of water main on North Avenue between Western Avenue and Prospect Avenue, as well as on Oak Avenue between Lake Street and Bartlett Avenue will be replaced. This water main replacement project also will include full lead service replacements for those homes/businesses along North Avenue and Oak Avenue. **Update:** The week of 6/10 crews will continue to install water main north of Morse Avenue to Lake Street. Oak Avenue will likely be closed at Lake Street for a few days when the contractor is working north of the school to Lake Street.

#### **Project Name: Devon Excess Flow Plant Rehabilitation**

**Description:** This project consists of a new lift station and force main to allow all excess Cook County flow to travel to the Bittersweet Water Reclamation Facility. This allows the village to eliminate the Devon excess flow facility.

**Update:** The contractor has completed concrete repairs and will start permanent pavement repairs the week of 6/10. Crews have also been working on landscape restoration.

#### **Project Name: Bittersweet Wastewater Treatment Plant Upgrades**

**Description:** Once complete, this multi-year (2021-2025) project will improve water quality for area residents and businesses in Bartlett by improving the treatment processes to meet the discharge limits set by IEPA, including the new limit for phosphorus.

**Update:** The contractor continues to grade and clean up the site. Also ongoing is refinement of the SCADA (Supervisory Control and Data Acquisition) system, consisting of both software and hardware, used for controlling, monitoring, and analyzing industrial devices and processes. Expected substantial completion is August/September 2024.

#### **Project Name: Country Creek Streambank Stabilization**



**Description:** The Village of Bartlett has been working with residents and other agencies to address the erosion along "Country Creek." As a part of this effort, the village has partnered with contractor Baxter & Woodman and the Bartlett Park District to perform streambank stabilization and native planting restoration along the creek from Francine heading southeast towards Stearns Road, adjacent to the park and soccer fields in this area. This work will happen in phases each year along the park district and village properties heading towards Stearns.

The village was also notified by homeowners along the creek of severe erosion adjacent to their homes. Consulting firm Hampton, Lenzini and Renwick (HLR) has been hired to look into the issue and see what can be done to remedy the erosion.

**Update:** Village staff has talked with a majority of the homeowners adjacent to the creek and next will be meeting with HLR to discuss moving forward with design and easements.



### **Project Name: Water Tower Painting**

**Description:** This multi-year project consists of sandblasting and painting some of Bartlett's elevated and ground storage water tanks.

#### FY2023-2024 & FY2024-2025: Schick Water Tower

**Update:** The contractor has been working on the inside of the tank. The company is bringing more equipment and people to get it painted and expects to complete the project before the end of June.

## **OTHER PROJECTS**

#### Project Name: IL Route 59 & W. Bartlett Road Improvements

Jurisdiction: Illinois Department of Transportation (IDOT)

**Description:** The intersection of Rt 59 & West Bartlett Road improvements include dual left turn lanes and right turn lanes on all four legs of the intersection (similar to the Rt 59 & Stearns Road intersection). It will also include traffic signal modernization and intersection lighting.

**Update:** After Memorial Day, IDOT began patching the inside lanes of IL Route 59. As this work takes place, Rt 59 will be down to one lane. IDOT will put up changeable message signs to alert drivers to the traffic configuration.

Next steps following IDOT's pavement work include final pavement markings and landscape restoration. For comments, questions, or concerns, please contact the IDOT Region 1 office at 847-705-4401.

#### Project Name: County Farm Road, RR Grade Crossing Renewal

Jurisdiction: DuPage County

Project Dates: June 24 to June 28

**Description:** Canadian National Railroad will shut down County Farm Road between Schick Road and Army Trail Road for four days, beginning Monday, 6/24, to make improvements to the RR crossing. Detour signs will be posted.
