Deputy Chief Naydenoff provided an update regarding the current entry level police officer hiring process. He advised approximately seventy-seven to seventy-eight (77-78) applications were submitted. He also informed the Board members the next academy dates are April 29, 2024, for Suburban Law Enforcement Academy (SLEA) and May 6, 2024, for Police Training Institute (PTI). Deputy Chief Naydenoff advised the written examination will take place the first week of April and the oral interviews will take place April 26 and April 27, 2024, for a September academy date. Deputy Chief Naydenoff reminded the Board members there is one (1) position being reserved for a previously approved candidate once he returns from his military deployment.

Deputy Chief Naydenoff provided the Board members with an update on the changes made to the Rules and Regulations. He informed all members present that the new changes will go into effect on March 16, 2024.
