SUBJECT:	Video Gaming

The Village of Bartlett has received \$90,661.71 in gaming revenue this year through August, 2015. At the present time, these funds are being held back from distribution by the State. The Village Board asked that staff identify a particular use for at least a portion this revenue stream. Uses such as the construction of bike paths and path enhancements such as map kiosks, storm water utility projects, road maintenance (until MFT funds are again distributed by the State) and recognition of our 125<sup>th</sup> anniversary of incorporation in 2016 are options staff would offer for consideration. A copy of a more detailed revenue analysis is attached for your review.

Re: Video Gaming Analysis

Video gaming in Bartlett Started in November, 2012 and the Village currently has nine (9) businesses with video gaming machines. Since 2012, the video gaming machines have generated \$211,502.96 for the Village. August 2015 was the highest revenue month for the Village (\$12,882.32). Papa Pacino's is not currently in business and reopened under a new name, Platform 18, which kept the video game machines. Sheep and Fiddle is not in business anymore, so they no longer have gaming machines. Tipsi Monkey took their terminals out in July 2014 and Tokyo Steakhouse II stopped video gaming half way through August 2014. These were inspected by staff to ensure that the same number of terminals were there, that were claimed. Staff will continue to monitor these monthly and update the list accordingly.

**Bracht's Place** was one of two establishments to receive video gaming in November 2012. Bracht's Place added a 5<sup>th</sup> video gaming machine in July 2014. The average monthly revenue for the Village from Bracht's Place is \$1,481.72. The total revenue made by the Village from Bracht's Place gaming sales is \$50,378.39.

**Bannerman's Sports Grill** (Friedman) was the other establishment to receive video gaming in November 2012. The average monthly revenue for the Village from Bannerman's Sports Grill is \$1,184.21. The total revenue made by the Village from Bannerman's gaming sales is \$40,263.19.

**Cadillac Ranch Texas BBQ** was the 4<sup>th</sup> establishment to receive video gaming after Tipsi Monkey, in June 2013. The average monthly revenue for the Village from Cadillac Ranch is \$699.90. The total revenue made by the Village from Cadillac Ranch's gaming sales is \$18,184.58.

**McMae's Tavern and Grill** (McCaffrey) was the 6<sup>th</sup> establishment to receive video gaming, after Sheep and Fiddle, in November 2013. The average monthly revenue for the Village from McMae's is \$276.37. The total revenue made by the Village from McMae's Tavern and Grill's gaming sales is \$6,080.02.

**Stella's Place** was the 7<sup>th</sup> establishment to receive video gaming, in January 2014. The average monthly revenue for the Village from Stella's Place is \$2,243.18. The total revenue made by the Village from Stella's gaming sales is \$44,863.54.

**Betty's Bistro** (Blackhawk) was the 8<sup>th</sup> establishment to receive video gaming, in March 2014. The average monthly revenue for the Village from Betty's Bistro is \$2,003.73. The total revenue made by the Village from Betty's gaming sales is \$36,067.11.

**O'Hare Pub and Restaurant** (O'Hare and Vance) was the 9<sup>th</sup> establishment to receive video gaming, in May 2014. The average monthly revenue for the Village from O'Hare Pub and Restaurant is \$309.96. The total revenue made by the Village from O'Hare's gaming sales is \$4,959.32.

**Shelby's** (Brewster Creek) was the 12<sup>th</sup> establishment to receive video gaming, after Papa Pacino's, in April 2015. The average monthly revenue for the Village from Shelby's is \$1,416.47. The total revenue made by the Village from Shelby's gaming sales is \$7,082.36

**Platform 18**: (Formerly Papa Pacino's) is the 13<sup>th</sup> establishment to have video gaming. It was previously Papa Pacino's until the owner closed down for renovations under a new name. They kept the old video gaming terminals and opened for business in August 2015. The average and current total monthly revenue for the Village from Platform 18 is \$10.75.

#### The last four with Red headings no longer have video gaming machines

**Tipsi Monkey** was the 3rd establishment to receive video gaming, in February 2013. They took out their gaming machines in August 2014. The average monthly revenue for the Village from Tipsi Monkey was \$56.45. The total revenue made by the Village from Tipsi Monkey's gaming sales was \$1,134.64.

**Sheep and Fiddle (Staley Management)** was the 5th establishment to receive video gaming, in October 2013. The restaurant closed soon after and the O'Hare Pub and Restaurant is now in its place. The average monthly revenue for the Village from Sheep and Fiddle was \$16.59. The total revenue made by the Village from Sheep and Fiddle's gaming sales was \$33.17

**Tokyo Steakhouse II** was the 10th establishment to receive video gaming, in June 2014. They took out their gaming machines in August 2014. The average monthly revenue for the Village from Tokyo Steakhouse II was \$31.98. The total revenue made by the village from Tokyo Steakhouse's gaming sales was \$95.93.

**Papa Pacino's** (Downtown Bartlett) was the 11<sup>th</sup> establishment to receive video gaming, after Tokyo Steakhouse II, in September 2014. The average monthly revenue for the Village from Papa Pacino's is \$230.00. Not on the list for July 2015, as they were restructuring their business mode, Platform 18 is now the title, and they have video gaming. The total revenue made by the Village from Papa Pacino's gaming sales was \$2,300.03

Re:	Video Gaming Terminal License

Staff was asked to look at what we charge in comparison to other communities for a terminal fee. Currently The Village of Bartlett charges a fee of \$25 per machine, per year. The vendor is required to have a Village sticker on each machine. The Village then keeps those numbers on file. Non-home rule communities are capped by the State at \$25. According to the legal department at the Illinois Gaming Board (conversation on 9/3), there is pending litigation regarding home rule communities.

2015 Proposed Property Tax Levy SUBJECT:

Below is a chart showing the proposed 2015 levy and comparing it to the 2014 extension. The proposed property tax levy for 2015 totals \$9,265,478. The General corporate levy is decreasing 1% from the 2014 extension and is flat from last year's levy amount. The General Corporate levy is down \$700,000 from 2012. This is the 6<sup>th</sup> consecutive year the Village has either reduced or kept this levy flat from the 2009 levy. The Police Pension levy decreased due to positive actuarial results of the Pension Fund. We are proposing to keep the Debt Service Levy flat from the 2014 levy. Abatement ordinances will be provided in December in order to keep this levy flat. Dollars will be used from Brewster Creek TIF Fund and the Debt Service Fund to accomplish this. The total levy dollar amount has decreased by \$174,416 or 1.85% from 2014.

#### Abatements

Currently, there are two abatements being proposed in the amount of \$284,225. The 2007 bond issue requires a payment in the amount of \$43,770 for the Fire Districts share of bonds attributable to the construction of the fire station. Also, a transfer of \$29,880 is to be transferred from the Brewster Creek TIF Municipal fund to the Debt Service fund to pay for its portion of the bonds. The second abatement in the amount of \$210,575 is to reduce the 2012 Road Bonds and 2009 refunding bonds in order to keep the Debt Service levy flat from prior years. Dollars to fund the abatement will come from the Debt Service Fund. Abatement ordinances will be presented with the final approval of the tax levy on December 1, 2015. The chart below itemizes the proposed debt service levy and abatement for 2015.

**2012** *Road Resurfacing Bonds* – This bond issue was sold in 2012. The 2012 bonds are being used to fund street improvements and a portion of flood mitigation for Heartwood Farms. The final maturity on these bonds will be in 2030.

**2009** *Refunding* - This bond issue was sold to refund the 2002 and 2005 bonds. The 2002 bonds were used to fund the ball fields, W. Bartlett/Naperville Road bike path, and W. Bartlett Road widening. The 2005 bonds were issued to finance the water meter change out program and most of the construction of the new Village Hall. This issue will be retired 12/15/2029.

**2007** *Fire Station* – This bond issue was sold in November 2007 to finance construction of a fire station on the west side. Abatements are

based upon revenues from the Brewster Creek TIF Municipal Account and Fire District shares of the annual debt service. The issue will mature in 2026.

**Equalized Assessed Value (EAV)** 

Above is a chart showing the actual EAV for the last 10 years along with the estimate for 2015. The overall EAV estimate for 2015 assumes that EAV will decrease by 2%.

In DuPage County, the estimate for EAV is an increase of 2%. In 2014, EAV decreased in DuPage County by 2.48%.

The estimate for Cook County assumes a 2% increase in EAV. Cook County finalized its EAV's for 2014 in August. The EAV in Cook increased 1.87% in 2014.

#### **Estimated Tax Rates**

Below is a chart showing an estimate of the 2015 Cook County rate. The rate is anticipated to decrease in Cook County by 5.78 cents.

SUBJECT: Utility Tax Discussion and Follow up

At the Committee meeting on September 15, 2015, the Committee wanted additional information on the Electric and Gas Utility Tax. I have researched the questions that were asked pertaining to the utility tax.

Currently, the Village charges 5 cents per therm for natural gas. 5 cents is the maximum amount the Village can charge per state statute. State statute does not provide for a fixed fee to be assessed for a resident or business for taxing Natural Gas.

The Electric Utility Tax has a max rate of .061 cents per kilowatt hour (KWH) used. Com Ed adds an additional 3% to the rate for administrative costs. The Village's current rate is .0146 cents per KWH for the first 2,000 used in a month. The rate decreases as the amount of KWH used increases. The maximum amount of revenue the Village can generate based on the max rate of .061 KWH is approximately \$1,300,000.

I have attached a chart that looks at the current rates charged for both the Gas and Electric and Utility Tax by our neighboring municipalities.

**SUBJECT:** Food and Beverage Tax

Per your request, I have looked at the amount of revenue the Village of Bartlett would generate if it were to establish a Food and Beverage (F&B) tax based on a 1%, 2%, 3% and 4% tax. In calendar year 2014, the Village collected \$284,000 in sales taxes from drinking and eating establishments. The Village also has 43 businesses that are classified as drinking and eating places under the state's sales tax criteria. Unfortunately, the State does not separate what is generated in food and beverage. Based on the aforementioned, we can assume a 1% F&B tax would generate \$284,000, 2% would generate \$568,000, 3% would generate \$852,000 and 4% would generate \$1,136,000.

I also looked at some similar communities that have F&B tax. The Village of Hanover Park has a 3% F&B tax and generated \$1,036,661 in 2014; Streamwood has a 2% tax and generated \$1,192,895; Villa Park has a 1.5% tax and generated \$537,365 and Glendale Heights has a 1% tax and generated \$470,458.

I have attached the monthly remittance form that Streamwood uses to collect the F&B tax along with their ordinance. Also, attached is a listing of "other revenues" municipalities have implemented. The data came from the annual DuPage Mayors and Managers survey on municipal revenues for 2014.

Trustee Hopkins also asked for a history on our Electric and Gas tax. In Fiscal Year 2013 the Village collected \$1,482,693. This was based on 10 months of collections. In 2014 the Village collected \$1,704,373 and in 2015 we collected \$1,705,763. Both Com Ed and Nicor Gas do not give any data on what is generated from business or residential.
